Theoretical part is carried out using e-learning teaching methods. Successful completion of an e-learning course is a required to obtain credits.

- Detailed information on e-learning course are provided during the first lesson.
- Instruction how to work with LMS Moodle is available from <<https://utpo.lf1.cuni.cz/en/lms-moodle>>.
- Time schedule to complete particular parts of e-learning course are available in the orientation section.
- Compulsory and recommended learning resources for particular topics are part of the e-learning course.
- Study progress can be checked in section “Grades”.
- Pre-class learning, attendance and participation on training session is part of evaluation for each particular section.
- Requirements to complete the e-learning course successfully include:
 - overall score at least 80 %,
 - score for each course section including final at least 80 %.

Skills training is organized in small groups of students. The list of available skills training sessions for each course section is available via e-learning course. Student register for one session in each course section.

During skills training session students:

- wear the student ID card,
- maintain common hygiene standards (*washing hand, no food, no drinks and chewing gums during work with mannequins*),
- are dressed and equipped so that the skills training is feasible and infection control measures can be followed (*absence of jewellery and watches on hands, longer hair pulled back, etc.*),
- follow the teacher's instructions.

Credits are awarded under the following conditions:

- 1) Successful completion of e-learning course (*details above*) during the current academic year,
- 2) Attendance and adequate performance on at least 80% of sessions (*on-line and face-to-face*) during the current academic year.

In case of the **attendance is missing** for skills training session, the student prepares the presentation and demonstration of practical skills lasting at least 10 minutes. The topic is assigned by the teacher. The written presentation has to be uploaded before deadline and using the link in e-learning course. The dates of the oral presentation are available in the final part of the e-learning course. Assessment of the presentation is a part of the overall assessment.

In case of **attendance is missing** for more than 20% of skills training sessions, individual theoretical and practical verification of knowledge is required.

- 3) Participation and relevant performance during final skills training session of the current academic year.

In case of absence, lack of participation or inadequate performance, individual theoretical and practical verification of knowledge is required. Points 1 has to be completed before registration for verification of knowledge.

There are not more than 3 attempts to complete verification of knowledge. **Prior** excuse of **responsible teacher** is required in order to change the date of verification. **Later** request to consider excuse is possible only for very serious and authorized reasons (*e.g. unplanned hospitalization*) and has to be addressed to **the head of study subject**.

The skills listed below can be confirmed to List of practical procedures during the final session:

- No. 4 (*Surgical Treatment of Uncomplicated Wound*),
- No 10 (*Collection of microbiological material for examination*),
- No. 11 (*Parenteral drug administration - i.v., i.m., s.c.*).

Procedures can be confirmed only under the condition the student was present and performed procedure during particular session. Skills can be confirmed only in academic year during which they were performed.
